3. After taking affiliation from CBSE New Delhi, the school management will undertake to give salaries and other allowances to all teaching and non-teaching staff of the school, as applicable to Government employees. In case of non-compliance, the No Objection Certificate will be withdrawn.
4. You yourself and your management will make sure that as and when any information is demanded by the District Education Officer or any other senior officer of the Education Department, the same will be provided along with required co-operation.
